Webb Recycle Program Details 2015

The objective of this program is for you, the contractor, to profit from your reclaimed R22 and other gases. The most prevalent gas will be R22 but there are others which could earn you money as well. This program will refer to R-22.

Contractor Role:

- 1. Return your filled tank of gas to Webb Supply. You will be issued a credit for the tank and will purchase a replacement tank. These offset with no cost to you.
- 2. Tanks must be 100% R-22 and must be at least 75% full to garner full benefit of this program.
- 3. If tanks have mixed refrigerant or are underweight, no credit will be given but the contractor will still receive a new certified tank.
- 4. Maximum benefits can only be obtained by following this simple rule: *Full tank and pure gas.*

Webb Supply Role:

- 1. Webb will weigh a return tank to determine how full the tank is and will return if it does not meet profit maximizing weight.
- 2. We will affix a tag that allows total visibility and tracking. This will allow contractor to determine if a specific tech is not following good reclaiming practices.
- 3. We will turn in all tanks and provide accurate record keeping and reporting.
- 4. We will issue appropriate credit in a timely manner to a Rebate customer or advise Clean and Return customer of tanks available to purchase.
- 5. For Rebate customers, Webb Supply will credit your account at the rate of \$1.50 per pound of confirmed pure R22. (Rebate amount may change based on refrigerant market conditions and quality returned).
- 6. Clean and Return customers will have the opportunity to purchase a new jug of R22 at the discounted cost of \$269.00 for every 30lbs of confirmed pure R22 returned. Customer has 60 days from point of notification to purchase or, the contractor will be paid out at the current rebate.
